

**Contract # 2010-11-WBH-TX
AMENDMENT #1**

PURPOSE OF THE CHANGE: To amend the contract between **Willapa Behavioral Health** and **Pacific County**.

IT IS MUTUALLY AGREED THEREFORE: That the contract is hereby amended as follows:

1. A portion of state grant in aid funds (\$12,221) for fiscal year 2011 are substituted with Title XIX/Medicaid funds (a net zero result). A line item detailing this fund swap is included in Exhibit A- Budget, Amendment #1. The Title XIX/Medicaid funds may only be used for allowable treatment costs for Disability Lifeline and ADATSA eligible clients.
2. Total direct bill CJTA budget is decreased by \$8,256.73 and Title XIX set aside budget is increased by \$8,256.73 due to faster than expected expenditure of Title XIX CJTA funds and to ensure adequate set aside funds are available for remainder of fiscal year 2011.
3. An increase in CJTA innovative funds of \$2,278. These funds are to be used to pay for allowable treatment costs for drug court clients only.
4. A decrease in federal SAPT funds of \$133.47.
5. Exhibit A-Budget is amended and replaced in its entirety. Total contract consideration increases by \$6273.80.

ALL OTHER TERMS & CONDITIONS of the original contract shall remain in full force and effect.
