

This Contract between the State of Washington Department of Social and Health Services (DSHS) and the Contractor is hereby amended as follows:

1. **Purpose.** The purpose of this Amendment is to reduce the maximum consideration payable under the Contract in order to implement budget reductions pursuant to Executive Order 10-04 issued by the Governor requiring across-the-board reductions of 6.287% in spending authority for all agencies with General Fund-State (GF-S) appropriations.
2. **Effective Date of Amendment.** This Amendment shall be effective as of the start date indicated on page 1 under "Amendment Start Date."

The Special Terms and Conditions are amended as follows:

3. **Section 5. Budget Exhibit** is amended as follows:

If payment for services is based on actual costs or equal monthly payments and the Contractor's budget for providing services under this contract is attached as an exhibit to the original Contract, it is prorated accordingly to reflect the above stated Vendor Rate Decrease of 6.287%.

Contractors, who require revisions to specific individual line items, may submit a revised Budget for consideration to the DSHS contact stated on page 1 of this Amendment. If approved by DSHS, the revised Budget will be signed and dated by both parties and incorporated into this Contract by an additional Amendment.

All contract references to the Budget Exhibit are hereby amended to refer to the revised Budget.

4. **Section 6. Consideration, subsections a. and c. are amended as follows:**

- a. **Maximum Contract Amount.** The maximum amount of total consideration payable to the Contractor for satisfactory performance of work under this Contract is reduced by the amount shown on page 1 of this Amendment under "Amount of Increase or Decrease" for the new "Total Maximum Contract Amount" shown on page 1 of this Amendment.
- c. **Vendor Rate Increase or Decrease.** In the event of a legislatively mandated vendor rate increase or decrease for the services under this Contract, the rates under this Contract shall be adjusted accordingly and incorporated into this Contract as of the date the new rate becomes effective.

5. **Section 6. Consideration, subsection d. "Rate of Payment" is amended as follows, depending on the Contractor's payment type as identified in the original Contract as actual costs, equal monthly payments or hourly rate:**

Actual Costs. DSHS will pay the Contractor a reduced amount, according to the Contractor's revised budget for actual costs related to services provided during the period of this Amendment.

Equal Monthly Payment. DSHS will pay the Contractor a revised equal monthly payment, calculated by subtracting the total dollar amount of the equal monthly payments paid and/or scheduled through

November 30, 2010 from the new Total Maximum Contract Amount and dividing that subtotal by the number of months remaining in the contract period.

- The number of families to be served under this contract is ~~5000~~.

Hourly. DSHS will pay the Contractor at the rate stated in the original Contract within the reduced maximum consideration stated on page 1 of this Amendment.

All other terms and conditions of this Contract remain in full force and effect.
