

PROFESSIONAL SERVICES CONTRACT
FOR
RECYCLING DROP BOX SERVICE
Amendment No. 6

This amendment is made as of the _____ day of _____, 2022 among Pacific County, a municipal corporation and Peninsula Sanitation Service, Inc., a Washington corporation and amends the existing PROFESSIONAL SERVICES CONTRACT FOR RECYCLING DROP BOX SERVICE executed as of the 12th day of June 2012.

This amendment shall become effective on the 1st day of April, 2022 and contain the following amendments:

1. Section III. DURATION OF AGREEMENT

This agreement shall now terminate on October 31st, 2022.

2. Section V. COMPENSATION AND METHOD OF PAYMENT

A new price, based on time and materials, of \$353.73. per service charge minus 50% of the market value of the recyclable materials contained within and immediately adjacent to the recycling drop boxes will be in effect during this amended contract time.

All other terms and conditions of the PROFESSIONAL SERVICES CONTRACT FOR RECYCLING DROP BOX SERVICE executed on the 12th day of June 2012, and not specifically mentioned above will remain the same.

Dear Mr. Humphreys,

We at Peninsula Sanitation are sending this correspondence to inform Pacific County that we would like to extend our current Professional Service Contract for Drop Box Service with Pacific County. As we have discussed we would like to propose changes to the system but are not in a position to do so by the end of the current extension that is set to expire April 1st 2022. We would like to extend the current agreement for six months to expire on October 31st 2022. It is our intention to have a proposal to you well before this date and if an agreement is made before the end of this extension there is a 30 day termination clause in the contract that could be invoked.

With this extension we ask that the current price as of May 1st, 2022 include a CPI adjustment of 6.8%. This increase is based on the December-to-December Consumer Price Index for Pacific Cities and US City Average - West Size Class A. The new rate would be \$353.73 per haul which includes the 3.6% State Refuse tax.

We appreciate your consideration and look forward to partnering with Pacific County on this program.
