**Amendment #1**

WHEREAS, the Contract for Services (CONTRACT) between Pacific County (COUNTY) and the Pacific County Economic Development Council (RECIPIENT), effective the 1<sup>st</sup> of July, 2011, allows for amendment to the duration, general scope of the CONTRACT and/or the services to be performed; and

WHEREAS, the Pacific County Economic Development Council is facing cash flow constraints due to the current economic climate; and

WHEREAS provision of full funding for this project by the COUNTY at the beginning of the project will allow for completion of the scope of work in a manner satisfactory to both parties;

NOW, THEREFORE, the following Amendment shall replace Section 1 (Funding):

### **1. FUNDING**

Twenty thousand dollars (\$20,000) has been pledged within Pacific County Public Facilities Improvement Fund No. 126 to assist the RECIPIENT with this "public facility" improvement. Said amount shall constitute the maximum reimbursement the RECEIPT is eligible to receive from the COUNTY under this CONTRACT. These funds are to be dispersed as follows:

- Ten thousand (\$10,000) will be paid in one "up front" payment during the 2011 calendar year
- Ten thousand (\$10,000) will be dispersed on a cost reimbursement basis as provided in Section 5 (Payment Provisions)

All other terms and conditions within the CONTRACT shall remain the same.
