CONTRACT AMENDMENT NO. 3

PURPOSE OF CHANGE: To amend that Basic Agreement dated July 1, 2017, between Great Rivers Behavioral Health Organization DBA Coastal Administrative Systems (hereinafter referred to as "**CAS**") and Pacific County (hereinafter referred to as the "**County**").

IT IS MUTUALLY AGREED THEREFORE: That the agreement is hereby amended as follows:

1. All references to Great Rivers Behavioral Health Organization, LLC ("BHO") shall be removed in its entirety and replaced with "Great Rivers Behavioral Health Organization, LLC dba Coastal Administrative Systems ("CAS)".

2. Section 2.1.2 is replaced in its entirety by the following:

Maximum allowable compensation under this Agreement for Professional Services shall not exceed \$140,904.00.

3. Section 2.3 is replaced in its entirety by the following:

2.3 Term and Termination. This Agreement shall continue until **June 29, 2021**, subject to termination by either party upon (30) days written notice to the other party.

4. Statement of Work, Section 4.5., is replaced in its entirety by the following:

4.5. Service Area. The County shall provide services within Pacific County with occasional support to Wahkiakum County on an as needed basis.

ALL OTHER TERMS AND CONDITIONS of the original contract and any subsequent amendments thereto remain in full force and effect.
