DESCRIPTION/JUSTIFICATION OF AMENDMENT: <p>The U.S. Department of Homeland Security (DHS), Federal Emergency Management Agency (FEMA) is providing funds to enhance the capability of state and local units of government to prevent, deter, respond to, and recover from catastrophic and/or terrorist events through the FFY09 Homeland Security Grant, State Homeland Security Program. This funding is being provided to address the unique exercise, training, planning, equipment, organization, and management and administration needs of emergency responders.</p> <p>Region Lead, Thurston County, in contract E10-248, revised their budget to redistribute \$41,200 to Pacific County for additional purchases of approved equipment. In addition, Pacific County has requested an extension to complete contract deliverables, and to ensure all equipment purchased under this contract has been received, installed, and tested. Re-distribution of these funds is allowable under the grant provisions.</p>

Change the overall contract amount from \$51,193 to \$92,393; an increase of \$41,200. 3.
