Amendment #5- CCAP STATE HOUSING CONTRACT

PURPOSE OF THE CHANGE: To amend the contract between Coastal Community Action Program (CCAP) and Pacific County.

IT IS MUTUTALLY AGREED AND THEREFORE THE CONTRACT IS HEREBY AMENDED AS FOLLOWS:

1. Pacific County is electing to amend the CCAP's contract for the Consolidated Homeless Grant/Housing and Essential Needs from the Washington State Department of Commerce to include the new GA Recording Fees amount for December 1st, 2022- November 30th, 2023.
2. Pacific County is electing to amend the CCAP's contract for the Consolidated Homeless Grant/Housing and Essential Needs from the Washington State Department of Commerce to include the PSH CHF: Rent/FAC Support Lease and PSH CHF: Operations funds for February 1st, 2023 – June 30th, 2023. These funds will be used to match the HUD PSH program.
3. A new budget, labeled as Amendment #5 Budget, provides the budget for the contract.
