Amendment #1- CCAP STATE HOUSING CONTRACT

PURPOSE OF THE CHANGE: To amend the contract between Coastal Community Action Program (CCAP) and Pacific County.

IT IS MUTUTALLY AGREED AND THEREFORE THE CONTRACT IS HEREBY AMENDED AS FOLLOWS:

1. Pacific County wishes to extend the 6-month performance Contract executed and agreed to on August 9, 2019 by both parties. By mutual agreement, the Contract will be extended until June 30, 2020 assuming all other terms and conditions of the original Contract are met.
2. Exhibit G- Transition Period will be removed as Pacific County does not elect to transition the program back to Pacific County by January 1, 2020.
3. A new budget for January 1, 2020 to June 30, 2020 is outlined in Exhibit E- Budget, Amendment # 1.
4. As part of receiving General Administration Recording Fees funding, CCAP agrees to pay application fees for Pacific County HUD Permanent Supportive Housing clients out of the Recording Fees provided to them by Pacific County.

ALL OTHER TERMS AND CONDITIONS of the original contract shall remain in full force and effect.

This Amendment shall be effective once signed by both parties.
