

**PACIFIC COUNTY
COMMUNICATIONS FACILITY USE AGREEMENT
Amendment #1**

WHEREAS, Pacific County owns, operates, and maintains certain communications facilities through the COUNTY for the usage by municipal, local, and county government, and;

WHEREAS, such facilities are capable of supporting certain other communications systems without degrading or encumbering the COUNTY's systems, the COUNTY entered into this Site Use Agreement with **Centro Familiar Cristiano** (hereinafter called **KGIO**), on the 26th day of May, 2020, and;

WHEREAS, KGIO was bought by Growing Christian Foundation (hereinafter called **KCPL**), dated February 22, 2022; and

WHEREAS, Exhibit C, Section 6 Assignments and Subletting allows the assignee or transferee to have the right to assume the Use Agreement dated May 26, 2020 with all its terms and conditions for the remaining lease term; and

WHEREAS, this AGREEMENT is in need of modification; and

WHEREAS, the COUNTY and KCPL, in their mutual interest, wish to replace the name Centro Familiar Cristiano with Growing Christian Foundation throughout the entire use agreement and Exhibits A, B and C, amend Exhibit C, Section 11. NOTICES and amend the equipment list and annual amount in Exhibit A.

NOW THEREFORE, the parties hereby agree that the following Amendment shall be as follows:

1. Remove all instances where the name Centro Familiar Cristiano appears in the use agreement and Exhibits A, B, and C and replace with the name Growing Christian Foundation.

2. Update item 11 in Exhibit C.
