**Contract Agreement for ATM Services**

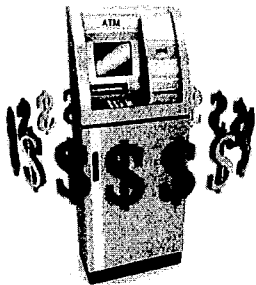
**J & B Vaulting agrees to provide 1 ATM with J&B Vaulting supplying the cash for the event \$30K.**

**J & B Vaulting Responsibilities Include:**

- A. Shipping & Delivery Based on Fee Structure Below. SEE FEE STRUCTURE, LINE E.
- B. Removal following the conclusion of the event
- C. Provide Network Port and Cable to Connect to Pacific County Internet Connection
- D. Provide maintenance & service of ATM as needed during the event
- E. Provide Signage and/ or Banners for this event
- F. Secure ATM with Screws or Chain or AS NEEDED \*If Available

**Event Responsibilities Include:**

- A. Provide a secure and sheltered location for ATM placement that is visible and accessible to the public.
- B. Event is responsible for any damage to ATM or Theft during the Event.
- C. Provide a 110v power source for the ATM(s) or Power Cords for Powering each unit.
- D. Provide 24 Hour Security OR Locked Facility Afterhours \*If an overnight event, that is responsible to Monitor the ATMs for Vandalism or Theft. \* Facility must contact Law Enforcement Immediately then contact J & B Vaulting no matter the time of night if anything was to occur. – Call us at 800-791-4856 (24/7)
- E. Provide Close Designated Parking near ATMs for Service.
- F. ATM(s) must be in a lighted or a light must be over the ATMs at Night for Security Purposes.
- G. Provide a network Ethernet port for high speed internet (NOT DIALUP) that we can connect our ATM to. We prefer DHCP for the internet IP Addresses however we can configure any IP Provided.

**Fee Structure:**


- A. J&B Vaulting Will Supply Cash
- B. Surcharge will be set at \$3.25
- C. Pacific County will receive \$0.25
- D. Discounted Delivery Fee of \$175.00 (Normally \$250 now due to fuel costs) for under 350 transactions will be applied. This will be billed to fairgrounds separately "if" you don't do at least 350 transactions on the ATM.
- E. Pacific County Fee Structure will be reimbursed via Check or ACH. \* A check will be sent to address and name provided and will arrive from Bandcard ATM roughly 30 days after the event. If however you do a ACH Form, you receive it auto deposit by 10<sup>th</sup> of September.
