This Contract between the State of Washington Department of Social and Health Services (DSHS) and the Contractor is hereby amended as follows:

1. **Purpose of Amendment.** The purpose of this Amendment is to extend the Contract for State Fiscal Year 2012 (FY12).
2. **Period of Performance.** The period of performance under this Contract is extended for the period July 1, 2011 through June 30, 2012, as indicated on page 1 of this Amendment.
3. **Maximum Contract Amount.** If this Contract has a Maximum Contract Amount, the maximum amount of total compensation payable to the Contractor for satisfactory performance of the work under this Amendment is increased by the amount shown on page 1 under "Amount of Increase or Decrease" for a new "Total Maximum Contract Amount" as shown on page 1 of this Amendment.
4. **Budget.** If the Contract requires a budget, the line item amounts and total amount of the current contract budget are prorated in accordance with the amount of increase or decrease stated on page 1 for this Amendment.

Contractors who require other than proportional revisions to specific individual line items, may submit a revised Budget for consideration to the DSHS contact stated on page 1 of this Amendment. If approved by DSHS, the revised Budget will be signed and dated by both parties and incorporated into the Contract as extended by an additional amendment.

All other terms and conditions of this Contract remain in full force and effect.
