

**INTERAGENCY AGREEMENT
Between
Pacific County
and the
Pacific Conservation District
(VSP 21-23 Amendment #2)**

WHEREAS, the interagency agreement between Pacific County and the Pacific Conservation District, effective the 1st day of July 2021, allows for amendments to the general scope of the Agreement and the services to be performed; and

WHEREAS, the Pacific Conservation District has made significant progress in providing the contractual services and products identified within the Agreement, and has, due to good management of resources, performed required tasks; and

WHEREAS, the amendment to the Interagency Agreement will enhance the services provided to the County, to the betterment of the residents of Pacific County;

NOW, THEREFORE, the following Amendment shall replace Section 2 of the original agreement:

- 2. PAYMENT.** The County agrees to reimburse the District for eligible costs not to exceed \$376,875.00 to perform the services described in Exhibit A and the projects outlined in Washington State Conservation Commission Formal Amendment #1 from the time period of July 1, 2021 through June 30, 2023. The payment requests shall be submitted monthly by the 10th and include all necessary documentation to support the payment request, including but not limited to: timesheets, composite rate sheets, mileage logs, documentation of outreach, etc. The County shall reimburse the District within two (2) weeks of a complete payment request submittal.

The rate calculated by using the Washington State Conservation Commission VSP Billing Composite Rate shall be used when calculating hourly rates for personnel.

All other terms and conditions within the Agreement shall remain the same.
