Amendment #1- DJHCC HOUSING CONTRACT

PURPOSE OF THE CHANGE: To amend the contract between Dylan Jude Harrell Community Center (DJHCC) and Pacific County.

IT IS MUTUTALLY AGREED AND THEREFORE THE CONTRACT IS HEREBY AMENDED AS FOLLOWS:

1. Pacific County is electing to amend the DJHCC's contract for the Consolidated Homeless Grant Eviction Prevention and Emergency Housing Fund from the Washington State Department of Commerce to move \$9,962 from CHG Eviction Prevention Admin and \$19,966 from CHG Eviction Prevention Rental Assistance to CHG Eviction Prevention Operations.
2. A new budget, labeled as Amendment #1 Budget, provides the budget for the contract.
